Higher Education Emergency Relief Fund (HEERF) Quarterly Report–January 10, 2022

Certification and Agreement

Glen Oaks Community College has signed and returned the HEERF Certification and Agreement forms to the Department of Education. The College intends to use the student portion of HEER funds to make emergency financial aid grants available to students.

Total Amount of Funds

GOCC received \$288,3407 the student portion of CARES/HEERF I and an additional \$288,341 from CRRSA AVEERII. Through the American Rescue Plan (ARP), GOCC received attion of \$1,115,620 for a total of \$1,692302 to be used for student emergency grant aid.

Amount of Emergency Aid Distributed The total amount of awarded grant funds fibris quarterly reporting period was628,693.72.

Estimated Total Number of Students Eligible

During this quarterly reporting period,067 students were eligible to receive emergency grant funds

Number of Students Awarded Emergency Grants During this quarterly reporting period 067 students received emergency grants.

Methods for Determining Eligibility and Distribution of Funds

The college followed the U.S. Department of Education (ED) guidelines to determine student eligibility for HEER funds. According to the ED, colleges and universities were required to prioritize grant funding to students with exceptional financial need, such as students who receive Pell grants. Students who did not receive Pell were still eligible for funding through an application process.

Based on the ED guidance, the committee elected to automatically block award grants for all Pell recipients. Pell students who did not apply for a grant received a block award amount (\$100500) based upon their Estimated Family Contribution (EFC) level and enrollment intensity (number of contact hours enrolled). Pell recipients who completed the application process had

the opportunity to receive funds (\$150-1000) in addition to the block award. The combined award was based upon three categories: financial need on the FAFSA (EFC), financial need as described on the student's application, and enrollment intensity. Applicants who did not file a FAFSA and/or who did not qualify for Pell were awarded grants (\$150-1000) based upon application information and enrollment intensity.

All currently enrolled, post-secondary eligible students received a grant award in the amount of three contact hours of in-district tuition (\$378), which is equivalent to one three-contact hour course. Pell recipients who were block awarded as stated above, received this additional funding. All dual enrolled high school students received checks in the amount of \$150-350 to help defray costs of educational expenses not covered by school districts through the Michigan Post-Secondary Enrollment Options Act. Award amounts for dual enrolled students were determined by number of credit hours enrolled.

Students had the option on the emergency grant application to elect whether they wanted the grants to be directly applied to their student account balance or whether they wanted a grant check mailed to the address on file with the college's Registrar's Office. Awards were transmitted to student account balances on October 20, 2021, and grant checks were mailed to post-secondary students on October 25, 2021. Dual enrolled high school students were transmitted funds on November 5, 2021, and checks were mailed on November 9, 2021.

Guidance Provided to Students

On September 13, 2021, the Vice President of Student Services notified all students via their college email of the availability of, and eligibility requirements of, HEERF. Included in this email was a list of Frequently Asked Questions (FAQs) to address the application process, award amounts, eligibility requirements, prioritization of funds, etc. Students were also notified that the HEER funds could be used toward any expenses associated with their cost of attendance, including tuition, textbooks, course materials, food, technology, housing, healthcare, transportation, childcare, etc. This communication was also posted on the glenoaks.edu/coronavirus web page created specifically for COVID-19 related updates. Information was provided to local media outlets and was also posted on the college's social media accounts.

The VP of Student Services informed students via email that, after applications were reviewed and awards were posted, students could view the award amounts in MyGOCC, the student portal.
